ARTIST AGREEMENT:

By submitting to the "Bridges: Sharing our Past to Enrich the Future" call, I _____ grant an irrevocable, perpetual, royalty-free, worldwide non-exclusive license to Hildegard Center for the Arts, to reproduce, distribute, display and create derivative works of all of my entered images and/or artist statement (always citing the entrant) in connection with the Bridges program and promotion and memorial of the program and/or the Hildegard Center for the Arts, in any media now or hereafter known, including, but not limited to: Display at a potential exhibition of selected photographers; publication of an online catalogue featuring select photographs; on the Hildegard website or other social media (watermarks will be placed in order to protect photographer's work), and use and display by the Hildegard Center for the Arts partnering organizations in the Bridges Project, the Nebraska Tourism Commission and the Nebraska State Historical Society. Entrants consent to Hildegard doing or omitting to do any act that would otherwise infringe the entrant's "moral rights" in their entries. Display or publication of any photograph on Hildegard's website does not guarantee selection for inclusion in the catalogue or exhibition. Hildegard will not be required to pay any consideration or seek any additional approval in connection with any such use. Additionally, by entering, each entrant grants to Hildegard the unrestricted right to use all statements made in connection with the "Bridges" Call, or choose not to do so, at their sole discretion. Hildegard will not be required to pay any additional consideration or seek any additional approval in connection with such use.

I hereby represent, and warrant that each of my entered images is an original work created solely by me, that each of my entries does not infringe on the copyrights, trademarks, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity, and that no other party has any right, title, claim, or interest in the photographs. I understand and acknowledge that if any of my entered images contain any material which is subject to the rights of third parties, and/or if any persons appear in any of my entries, I am responsible for obtaining, prior to my submission of the entries, any and all releases and consents necessary to permit the exhibition and use of the photographs in the manner set forth in this Agreement without additional compensation.

I also agree to adhere to the requirements, as listed in this entry form. I understand that if I have not followed the requirements stated in this entry form my entry may be excluded from selection and/or exhibition. The responsibility of Hildegard Center for the Arts will be to take care of any and all installation, exhibition, and dismantling of said exhibit in which my work may be included. I also understand that Hildegard is not liable or responsible for any damage to the work before it arrives, including damage caused by chosen shipping company. Finally, I understand and accept that the decision of the judges will be final and may in no way contest the status of my entry in exhibition or publication.
